

ORDINANCE NO. 2019-09

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS  
DETERMINED BY THE BUDGET COMMISSION AND  
AUTHORIZING THE NECESSARY TAX LEVIES AND  
CERTIFYING THEM TO THE COUNTY AUDITOR.**

Whereas, this Council in accordance with the provisions of law has previously adopted a tentative Tax Budget for this fiscal year commencing January 1, 2020; and

**WHEREAS**, the Budget Commission of Portage County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill tax limitation; therefore be it

**RESOLVED**, by the Council of the Village of Sugar Bush Knolls Portage County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further

**RESOLVED**, that there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Sugar Bush Knolls, Portage County, Ohio, two-thirds (2/3) of all members elected thereto concurring.

**SECTION 1.** That the Clerk be and is hereby authorized and directed to certify two copies of said Tax Levies form and two copies of this Resolution and to transmit same to the Auditor of Portage County, Ohio.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this Village, for which reason and other reasons manifest to this Council this Resolution is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
