

RESOLUTION 2019-02

"NECESSITY FOR REPLACEMENT OF 8.0 MILL TAX LEVY"

A Resolution declaring the necessity of and placing on the ballot a tax levy in excess of the ten mill limitation for the purpose of current expenses pursuant to Section 5705.19(A) of the Ohio Revised Code, requesting the Portage County Auditor to certify the total current tax valuation of the village the dollar amount of revenue that would be generated by the proposed tax levy, and declaring an emergency.

WHEREAS, the amount of taxes that may be raised within the ten mill limitations will be insufficient to provide an adequate amount for the necessary requirements of the Village of Sugar Bush Knolls, Portage County, Ohio; and

WHEREAS, the electors of the Village of Sugar Bush Knolls in Portage County Ohio on November 4, 2014, approved a renewal increase of a 8.0 mill levy for five years for the purpose of current expenses of the Village; and

WHEREAS, there is currently a 8.0 mill levy in excess of the ten mill limitation for the benefit of the Village of Sugar Bush Knolls for the purpose of current expenses, and as set forth more fully in ORC Section 5709.15(A), which was before the electorate in 2014, and expires at the end of 2019;

WHEREAS, a resolution declaring the necessity of levying a tax under ORC 5705.19(A) outside the ten mill limitation must be passed and certified to the County Auditor of Portage County in order to permit the Village Council to consider the levy of such tax, and must request pursuant to Section 5705.03(B) of the Ohio Revised Code that the County Auditor Certify to the Village Council the total current tax valuation of the Village of Sugar Bush Knolls and the dollar amount that would be generated by a replacement of the current 8.0 mills with a new tax levy for 8.0 mills;

NOW THEREFORE BE IT RESOLVED, by the Council of the Village of Sugar Bush Knolls, Portage County, Ohio with at least 2/3 of all member elected thereto concurring:

Section 1. That it is necessary to levy a replacement of the eight (8.0) mills to constitute a tax in excess of the ten mill limitation for the benefit of the Village of Sugar Bush Knolls under ORC Section 5705.19(A) for the following purpose:

"for the provision of current services"

as provided by the ORC Section 5705.19(A) at a rate not to exceed 8.0 mills for each one dollar of valuation for the tax years 2019, 2020, 2021, 2022, and 2023, and that it intends to submit the question of the replacement of the levy to the electors at an election on November 5, 2019 as authorized by Sections 5705.29(AS) and 5705.191 of the Ohio Revised Code.

Section 2. That this Village Council requests the Portage County Auditor to certify to it the total current tax valuation for the Village and the dollar amount of revenue that would be generated by the replacement of the current 8.0 mill tax levy specified in Section 1 with a new 8.0 mill tax levy.

Section 3. That the Village Clerk shall deliver a certified copy of this resolution to the County Auditor promptly upon adoption thereof.

Section 4. That it is hereby found and determined that all formal actions of the Village Council concerning and relating to this ordinance were adopted in an open meeting of this Village Council, and that all deliberations of this Village Council, and of its committees that resulted in such normal actions, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution is hereby declared to be an emergency measure necessary to preserve the public health, safety, morals, and general welfare of the inhabitants of the Village of Sugar Bush Knolls, Ohio and for the further reasons that this matter may be enacted and conveyed to the Portage County Board of Elections so that there is sufficient time to complete all of the proceedings required to place the 8.0 mills replacements tax levy on the November 5, 2019 ballot, and for which reasons and other reasons manifest to this Village Council, this resolution is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
