The Village of Sugar Bush Knolls elected to PROHIBIT the discharge of consumer grade fireworks in the Village. This does not include fireworks displayed by a licensed exhibitor with a permit.

PARAMEDICINE PROGRAM

A Community Paramedicine Provider (CPP) is a paramedic/RN that works to increase access to primary and preventive care and increase the quality of life for the residents in our community. A CPP can assess your home for safety hazards, provide health assessments and chronic disease monitoring, coordinate health services, provide referrals to community resources, provide hospital follow up care, organization of new and current medications, and educate on identified health care goals. This service is provided through Kent Fire and EMS.
